# WIQI-FM/FM News 101.1 CONTEST RULES "NAME OF CONTEST" CONTEST PERIOD: DATE/TIME TO DATE/TIME

## 1. Eligibility And Odds Of Winning:

- a. **NO PURCHASE NECESSARY** TO ENTER OR WIN, NOR WILL A PURCHASE IMPROVE ONE'S CHANCES OF WINNING. Odds of winning will depend on the number of eligible entries received.

# 4. How To Claim A Prize:

- a. Winner will be contacted via telephone by Q101 on Monday May 3, 2010.
- b. Winners agree to claim their prize as directed by the WIQI-FM Promotion Department. Prize redemption or collection may be made by picking up tickets at will call, turning in WIQI-FM release form & W9, prize mailed to winner, or other processes. In the event that a prize is mailed to the winner, pursuant to winner's prior written consent, winner assumes the risk of the prize's safe arrival.
